The Fountain City Classic, Inc. tailgating policy is intended to provide everyone with an enjoyable and safe environment while attending Fountain City Classic football games. The Fountain City Classic in conjunction with the Columbus Police Department hopes that you will enjoy yourself, while respecting the rights of others. These rules are intended to be general guidelines. **FCC reserves the right to modify these at any time for the safety and effective administration of the event**

Rules & Regulations

- Tailgating will be located in **LOTS - D, E, F, G and grassy areas** for a fee (*See Application*). Tailgater must submit payment along with the signed disclaimer before allowed to enter.
- The tailgating area will open at least (6) hours prior to game time, unless otherwise advertised. **No vehicles permitted in tailgating area after gates close . GATE WILL BE CLOSED AT 10:00 A.M. Saturday, November 5, 2011.** Patrons failing to arrive during this designated time will forfeit all fees.
- **Once vehicles leave tailgating area, re-entry WILL NOT be permitted.**
- All groups and individuals participating in tailgating are responsible for the proper collection and disposal of their trash, as well as, other debris such as charcoal. Trash containers will be provided throughout tailgate areas.
- **Please be advised, vehicles are allowed in your assigned space and all items, vehicles must fit within the allotted space purchased (ex. Small tent (2) spaces, only 1car and 1 tent can be parked in a small area.)**
- **Parking space does not come with the purchase of grassy area.**
- **LUMPKIN BLVD WILL BE CLOSED AT 10:00 A.M. SATURDAY MORNING!!!** Tailgaters will not be able to enter Lumpkin Blvd after **10:00 A.M on Saturday.** Parking will be available in the front parking lot of Civic Center. Please try to get all heavy equipment in tailgating area before **10:00 A.M. Saturday.**
- **No food may be sold without a proper FCC vending permit. NO FOOD will be sold in tailgating areas.**
- **PLEASE NOTE:** Tents and RV's must fit within the designated area and there can only be one (1) car within the RV Space. Parking decal should be visibly displayed and affixed to the driver's side windshield.
- Fire lanes must be maintained at all times. Any automobiles, tents, or RV's blocking fire lanes will be removed. Any vehicle removed will be towed by a wrecker service. All expenses for towing and storage shall be transferred to the owner. There will be no refunds for this violation.

- **SITE SETUP MAY BEGIN NO EARLIER THAN 3:00 P.M.ON "SET-UP DAY," THURSDAY (EARLY BIRD), NOVEMBER 3, AND MUST BE CLEARED AND CLEANED BY 8:00 P.M. ON SATURDAY, NOVEMBER 5, OR 2 HOURS AFTER THE GAME, WHICHEVER IS LATER. CLAIMING TAILGATE AREAS PRIOR TO "SET-UP DAY" IS PROHIBITED**

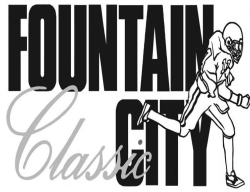

Verification of early bird tailgating spaces will be confirmed on site at Memorial Stadium starting Thursday, November 3, 2011 - 3:00 p.m.- 6:00 p.m. All other tailgaters may set up starting Friday, November 4, 2011 at 7:00 a.m. – 6:00 p.m and Saturday, November 5, 2011 at 7:00 a.m. – 8:00 p.m.**

Tailgaters purchasing permits online are **REQUIRED to print out a tailgating application**, fill out completely and submit via fax with **proof of online purchase**, as this will be necessary to redeem your tailgating location (**NO EXCEPTIONS**). The completed tailgating package can be faxed to the Fountain City Classic Office at 706-324-4082. **Online purchases for tailgating locations will end promptly on October 30, 2011 at 12:00 Midnight. (NO EXCEPTIONS)**. This permit must be displayed at all times and presented upon request. **Violators will be removed from premises by appropriate security and FCC, Inc. will not be liable. TAILGATING SPACE (S) CAN ONLY BE PURCHASE ONLINE OR AT SOUTH COMMONS AREA OF MEMORIAL STADIUM. TAILGATING SPACE(S) CAN NOT BE PURCHASED AT FOUNTAIN CITY CLASSIC OFFICE (NO EXCEPTIONS).** **Proof of online purchase will be necessary to redeem your tailgating location (NO EXCEPTIONS). FCC reserves the right to make any changes to this application for logistical purposes at anytime.**
